Tian at WIPO Assembly: A Balanced IP System is What We Need

The 48th Series of Meetings of the Assembly of the World Intellectual Property Organization (WIPO) was opened in Geneva, Switzerland on September 20. SIPO Commissioner Tian Lipu led the Chinese delegation with Vice Minister Fu Shuangjian from the State Administration for Industry and Commerce (SAIC) and Vice Minister Yan Xiaohong from the National Copyright Administration of China (NCAC) at deputies.

The first two-day of the 2010 Assemblies was reserved for a high-level segment, based on the theme "Innovation, Growth and Development: The Role of Intellectual Property and Member States' National Experiences". Speaking at meeting, Tian reviewed China's experiences in IP field during the 30 years' of reform and opening-up. He also proposed that the international society look at innovation in a wider view, treat IP protection in a more comprehensive standpoint, develop cooperation in a more open attitude and being tolerant in a broader chest to build a balanced and effective IP system for the international community at large.

Patent Filings from abroad Roll over 1M

With the climate favorable for IPR protection constantly improved, patent applications from abroad maintain strong momentum in recent years. As of September 9, 2010, SIPO had received a total of 1.002 million applications from abroad. In terms of types of patents, there are 865,000 for invention applications, 16,000 for utility models and 121,000 for designs.

The top 4 countries are Japan, the United States of America, Germany and the Republic of Korea with 361,000, 242,000, 89,000 and 81,000 patent

applications respectively, followed by France (37,000), Netherlands (35,000), Switzerland (27,000), the United Kingdom (22,000), Sweden (17,000), Italy (16,000) and Finland (10,000).

"Amendment of Measures on Patent Administrative Law Enforcement (Draft for Comment)" released

In order to implement national intellectual property (IP) strategy, adapt the amendment of patent law and its implementation rules and further consummate the patent administrative law enforcement, State Intellectual Property Office (SIPO) recently released

"Amendment of Measures on Patent Administrative Law Enforcement (Draft for Comment)" (hereinafter referred to as "Drafts"). The comments and suggestions from public can be submitted to SIPO by writing or e-mail, and the deadline is September 30, 2010.

According to the related principals of SIPO, the main purpose of the amendment is to ensure the law enforcement measures is consistent with the patent laws and implementation rules of patent laws and related regulations, and further standardize the behavior of patent administrative law enforcement. The "Drafts" enhances the responsibilities of SIPO in patent administrative law enforcement. The "Drafts" adds the regulations on commissioned law enforcement about SIPO and local IPOs' functions. Meanwhile, the "Drafts" puts forward provisions on standardizing the exercise of seizure means. reinforcing the mediation function of local IPOs, defining the cooperation between local IPOs and customs and consummating the procedure of administrative patent law enforcement. http://www.chinaipr.gov.cn/newsarticle/news/government/201009/

relationship, as well as made active contributions for the global IP protection.

According to statistics, in the first half year, the patent applications submitted to EPO by China exceeded were over 1,000 pieces, increased by 30% compared with the same period of last year; and the patent applications submitted to China by EU countries were more than 14,000 pieces.

Beijing to Grant Subsidiary for Patent Commercialization

Beijing launches subsidiary for patent commercialization on September 28. Patentees in Beijing can gain a maximum of 1 million yuan fund established by Beijing IP Office and Municipal Bureau of Finance for their qualified patent assignment and licensing activities.

According to the Beijing's Promotion Measures on Patent Commercialization, for the income-based patent transfer or license, the funding level is 5% for the part in excess of trade volume of 5 million yuan and the maximum aid financing is 500,000 yuan. For the transferee or licensee where their registration place is in Beijing, the funding level is 10% for the part in excess of 5 million yuan with the maximum of 1 million yuan.

China to Lead Global Innovation: Report

China is expected to lead in global patent activities by 2011, with significant rises in both the quality and quantity of patents, a Thomson Reuters analysis on intellectual property showed.

The report, published Monday by the IP Solutions business of the world's leading information source for businesses and professionals, said based on the total volume of first-patent filings in China, Europe, Japan, the Republic of Korea and the United States, both the U.S. and Japan will soon to be eclipsed by China's rising tide of patent applications.

China's patent applications by volume rose by 26.1 percent annually from 2003 to 2009, compared with its closest rival, the U.S., which showed a 5.5 percent growth rate, noted the report.

Further, according to the report, China's acceleration in innovation is government-driven, as the Chinese government has pledged to make the nation an innovation-centered economy through several incentives such as R&D tax deductions.

The report pointed out that the quality of Chinese patents is also slowly improving, as approximately half of all Chinese patents filed in 2009 were utility models, which are less-rigorous and more-affordable.

Besides, a major shift is taking place in Chinese patent filings as the country's economic landscape changes, it said, noting that agriculture-centered innovation, which is related to food production, is growing much more slowly than high-technology innovations.

There was a 4,861 percent increase in domestic Chinese patent applications in digital computers in the decade from 1998 to 2008, compared with a much more modest increase of 552 percent in those of natural products and polymers during the same period, the report said.
