## Judicial Decision to Protect Intellectual Property

China's top court is drafting a judicial interpretation to protect online intellectual property rights, which is expected to be released in January at the earliest. China currently has four laws and 19 regulations related to intellectual property rights protection, covering patents, trademarks and other fields.

### U.S. Initiates Probe into Chinese Products for Patent Infringement

The U.S. International Trade Commission (USITC) Friday launched a probe into certain products from China after several U.S. companies alleged their patents were infringed. The products in question include

televisions and Blu-ray players produced by Haier Group of China and Vizio Inc. under Taiwan-based Amtran Technology Company and sold in the U.S. market.

The trade panel is scheduled to set a target date for completing the investigation within 45 days after institution of the probe. If the complaint is approved, the agency will ban importation of those products.

China will keep its iron-handed policy in combating fake drugs in the upcoming year.

China launched a two-year special campaign for drug safety from July 2009 to July 2011, during which authorities investigated more than 42,000 cases and shut down 1,093 illegal websites.

#### China, U.S. Vow to Bolster Cooperation in IPR

Chinese Vice Premier Wang Qishan, together with US Secretary of Commerce John Bryson and U.S. Trade Representative Ron Kirk, cochaired the 22 Joint Commission on Commerce and Trade (JCCT) in Chengdu on November 21. The two sides expressed their willingness to expand bilateral cooperation in high-tech sector and strategic trade relations and deepen cooperation in IPR field. At the conference, the two sides also signed the China-United States Intellectual Property Rights (IPR) Cooperation Framework Agreement and other four economic and trade agreements.

#### Apple Loses Latest Count Fight over Samsung Smartphone

Apple Inc lost a request for a court order in its bid to block sales of Samsung Electronics Co's 4G smartphone and Galaxy Tab 10.1 tablet computer, according to a ruling that was posted on a court docket and then removed.

The iPad maker, in its lawsuit filed in federal court in San Jose, California, sought an order blocking Samsung from selling its Galaxy line of mobile devices products in the United States based on claims they violate Apple patents. The lawsuit is part of a legal battle between the companies being fought in 10 countries.
